#### Old Business

#### <u>501c4</u>

Dwight said we have our new EIN and the form to operate as a 501c4 has been filed, as of Tuesday, October 2<sup>nd</sup>, 2018. Dwight said he talked to his tax accountant, and was advised there shouldn't be any problems moving funds, as long as we are moving them from one charitable organization to another. Kevin was not sure because it's our equipment. After some discussion, it was decided that during the meeting, we would talk to emergency management about access to the equipment
